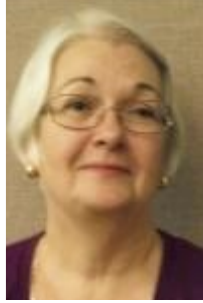

From the President

On March 23rd, I joined other members of the Saratoga, Rensselaer and Albany Leagues of Women Voters at Lobby Day at the Legislative Office Building in Albany. We spent a busy day meeting with our elected representatives to lobby for three specific issues related to the 2015-2016 Budget Bills before the legislature.

The three issues were ethics, campaign finance reform and the education investment tax credit. Governor Cuomo had connected all three issues to the passage of the budget bill. Here's what we lobbied for on each of these issues:

The League **supported** these Ethics Reform points:

- More complete disclosure of the outside earned income.
- Banning income received for services or referrals for legislative matters
- Per Diem reforms requiring receipts.
- Pension forfeiture for elected officials convicted of public corruption, subject to judicial review

The League **supported** these campaign finance reforms

- Reduction of contribution limits, restriction of contributions to housekeeping accounts, restriction on transfers from party committees to candidates, closure of the LLC loophole and clarification of the ban on personal use of campaign funds
- Public financing in New York state elections, reduction of campaign contribution limits to levels more consistent with federal limits and limits imposed by other states, limits on those doing business with the state, full closure of the LLC loophole, limiting candidates to one campaign committee
- Strong enforcement of these reforms by the State Board of Elections with the Attorney General having concurrent jurisdiction to prosecute criminal violations

The League **opposed** the Education Investment Incentives Act proposed in the Governor's budget which would provide tax credits to individuals and corporations for donations to private and public schools of their choice because

- it thwarts the allocation of education aid through a democratic and transparent process
- it is a regressive tax measure
- it would siphon off millions of dollars from the general fund, leaving less money for education and with no guarantee of increased funding for high-needs public schools.

The State budget passed on time but decisions on many of these issues have been deferred. We will be back in Albany in April or May, lobbying for issues of importance to the League. Why not join us next time, or if you cannot travel to Albany for the day, write or call your representatives to let them know that what matters to the League, **matters to you!**

Many of the malls and buildings built then are now looking at remodeling and reimagining and these towns are examining another model, that of the Town Center Concept, as they make plans for future development.

Clifton Park Town Supervisor Phil Barrett will join us on Tuesday, May 12th, at 7 pm at the Clifton Park Halfmoon Library to share what this concept looks like and how it will change growth and development in his town, especially around the Exit 9 interchange of the Northway. Also with us will be John Scavo, Director of Planning. Along with the Town Center Concept, they will share other projects which Clifton Park will be exploring in the coming years.

The meeting is open to all league members, and to members of the public, who are interested in learning more about this concept. Please join us for a lively conversation about these new planning ideas.

It comes up again for a vote in 2017. This is a limited update and Leagues are only being asked to vote to either approve the updated statement or retain the existing statement. 600+ Students Welcome Suffragists Back from the Grave



Thanks to a grant LWV Saratoga received from Soroptomists International of Saratoga County, Sojourner Truth, Elizabeth Cady Stanton and Susan B. Anthony have been paying visits to classrooms across Saratoga County.

Three local women each developed 30 minute one-woman shows (in collaboration with Patricia Nugent and Lezlie Dana, drama coach) to play the parts of SBA, ECS and Sojourner Truth. Each actress is performing 10 times. These first-hand accounts of the battle for women's suffrage also build interest and enthusiasm for voting. The 4th through 8th grade students really connect with the actresses and ask very thoughtful questions.

PROPOSED NEW BYLAWS OF THE LEAGUE OF WOMEN VOTERS OF SARATOGA COUNTY - 2015

These are the proposed changes in the bylaws that you will be voting on at the Annual Meeting. *[Deleted Material Is In Brackets and Italicized]* and New/Added Material Is Underlined. The complete current bylaws are posted on our website.

Bylaws of the League of Women Voters of Saratoga County

ARTICLE I Name

Section 1. Name. □ The name of this organization shall be The League of Women Voters of Saratoga County. This local league is an integral part of the League of Women Voters of the United States and of the League of Women Voters of New York State. *[The Leagues of Women Voters of Southern Saratoga County, (formerly, the Shenendehowa LWV) and of the Saratoga Springs Area merged in 1999]*

ARTICLE II Purpose and Policy

Section 2. Political Policy. □ *[The League of Women Voters of Saratoga County may take action on local government measures and policies in the public interest in conformity with the principles of the League of Women Voters of the United States. The League shall not support or oppose any political party or any candidate.]*

The League of Women Voters of Saratoga County shall not support or oppose any political party or any candidate. The League may take action on local government measures and policies in the public interest in conformity with the principles of the League of Women Voters of the United States.

ARTICLE III Membership

b. *[Associate members: All others who join the League shall be associate members. Associate members are non-voting members.]*

b. Non-Voting Members: All others who join the League shall be associate members.

ARTICLE IV Board of Directors

Section 1. Number. Manner of Selection and Terms of Office. □ The Board of Directors shall consist of the Officers of the League, six elected directors and not more than six appointed directors. Three

directors shall be elected by the general membership at each annual meeting and shall serve a term of two years, or until their successors have been elected *[and qualified]*. The elected members shall appoint such additional directors, *[not exceeding six]*, as they deem necessary to carry on the work of the League. The terms of office of the appointed directors shall be one year and shall expire at the conclusion of the next annual meeting.

Section 3. Vacancies. □ Any vacancy occurring in the Board of Directors by reason of resignation, death or disqualification of an officer or elected member may be filled, until the next annual meeting, by a majority vote of the remaining members of the Board of Directors in consultation with the nominating committee. □

[In the event that a board member is absent from three consecutive meetings or a total of four meetings within a fiscal year and not excused by the board of directors, that position may be declared vacant by a majority vote of the remaining board members.]

Any board member incurring 3 consecutive unexcused absences or a total of four meetings within a fiscal year shall be considered to have resigned from the board and that position may be declared vacant by a majority vote of the remaining board members.

Section 6. Quorum. □ A majority of the members of the board of directors shall constitute a quorum and shall decide its actions. *[a majority of the members in attendance at any board meeting shall, in the presence of a quorum, decide its action.]*

Section 7. Conflict of Interest Policy. Immediately following the annual meeting, all officers and board members [both on and off board] shall sign the conflict of interest form provided by the secretary.

ARTICLE V Officers

Section 4. The Secretary. □ The secretary shall keep minutes of all meetings of the League and of all the meetings of the board of directors. The secretary shall notify all officers and directors of their election. *[The secretary shall sign, with the president, all contracts and other instruments when so authorized by the board and shall perform such other functions as may be incident to the office.]* S/He shall maintain

the conflict of interest policy and forms. The secretary shall ensure that each officer and board member sign the conflict of interest forms and shall retain them until the next following annual meeting when they may be destroyed.

Section 5. Treasurer. □ The treasurer shall collect and receive all monies due. The treasurer shall be the custodian of these monies, shall deposit them in a bank designated by the board of directors, and shall disburse the same only upon order of the board. The treasurer shall present statements to the board at their regular meetings and an annual report to the annual meeting. The treasurer shall sign, with the president, all contracts and other instruments when so authorized by the board.

ARTICLE VI Financial Administration

Section 3: Budget Committee. □ A budget committee shall be appointed by the board of directors at least two months prior to the annual meeting to prepare a budget for the ensuing year. The proposed budget shall be sent to all members one month before the annual meeting. The treasurer shall not [be eligible to] serve as the chair of the budget committee.

Section 4. Budget. * [sections 3 and 4 have been reversed but the wording and intent are the same.]

Section 5. Auditor. An auditor to examine the books of the previous year shall be appointed each year by the annual meeting upon the recommendation of the Board of Directors. This person shall not be a member of the Board of Directors and may not serve more than two years in succession. The finding of the auditor shall be reported to the Board of Directors no later than the October Board Meeting of the same year .

ARTICLE VII Meetings

a. The annual meeting shall: □ (1) adopt a local program for the ensuing year; □ (2) elect officers and directors, plus three [3] members of the nominating committee; (3) adopt an adequate budget; □ (4) transact such other business as may properly come before it. □

a. ARTICLE IX Program

Section 3. Action by the Annual Meeting □

d. The program shall be adopted by an affirmative vote of the majority of members present at the annual meeting. □

ARTICLE X □ National Convention, State Convention and Council Section

Section 1. National Convention □ The board at a meeting shall select delegates to that convention in the number allotted to the League of Women Voters of Saratoga County.

Section 2. State Convention. □ The board at a meeting shall select delegates to that convention in the number allotted to the League of Women Voters of Saratoga County.

Section 3. State Council. □ The board at a meeting shall select delegates to that council in the number allotted to the League of Women Voters of Saratoga County.

ARTICLE XII Amendments

Section 1. Amendments. □ These bylaws may be amended by a two-thirds vote of the voting members present and voting at the annual meeting or other special meeting, provided that amendments were submitted to the membership in writing at least one month in advance of the meeting. The bylaws shall be reviewed at least every two years by a committee appointed by the Board of Directors.

WOMEN'S ISSUES ARE MOVING!

A.506, the Trafficking Victims Protection and Justice Act, one of the points of the Women's Equality Agenda (WEA), passed the Assembly on March 16 and is awaiting Gov. Cuomo's signature. The next day a Paid Family Leave Insurance (PFLI) bill providing for 12 weeks of leave passed the Assembly, and a Senate proposal for 6 weeks is reportedly in their budget. Negotiation and lobbying will be needed to make Paid Family Leave law. The Assembly passed **A.6221**, the reproductive rights bill on March 25, but this is the point that the Senate has so far refused to take up. Equal Pay Day is April 14, so the Assembly is poised to pass **A.6075**, the NY Equal Pay Bill, that makes it possible for employees to find out if they are receiving equal pay, when they return from recess the following week. The schedule for the remaining parts of the WEA, and for other bills important to women, is still fluid. Watch on the state League website for Memos in Support and action on these important women's issues.

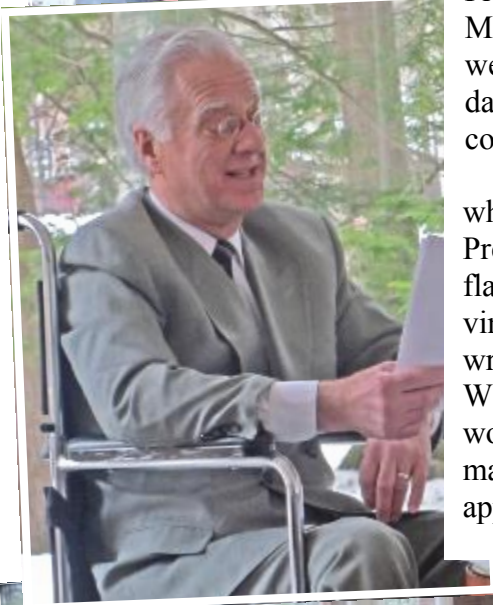
