TAKE ME TO VOTE! 2010- Saratoga County Fifth Graders Connect to Democracy in Action

As the kids went back to school this September, the Saratoga County League of Women Voters launched TAKE ME TO VOTE! 2010, to engage regional fifth graders in the real world of citizenship, democracy, and civic rights and responsibilities. Clearly aligned with the New York State grade 5 Social Studies Core Curriculum, TAKE ME TO VOTE! targets the fifth graders of the county and their teachers, motivating the learners to accompany their parents to the polls on Election Day, November 2, 2010.

Mary Ratzler, member of the county LWV board, and retired school librarian, reached out to the Washington Saratoga Warren Hamilton Essex BOCES School Library System, and its Director Paige Jaeger, to seek the involvement of the county's School Library Media Specialists. With a librarian in each school serving as a contact person and resource disseminator, over 2,500 students and almost 70 teachers received an almost personal invitation to participate in TAKE ME TO VOTE!.

Response to TAKE ME TO VOTE! was significant, with **1,440 students** going to the polls and receiving their League TAKE ME TO VOTE! Again button. **Sixty-one county grade five teachers** in 17 schools participated, which is approximately 70% of the county's teachers.

County Schools with the highest level of overall participation and classrooms with the highest percentage of participation will receive plaques from the Saratoga County League of Women Voters. Three classrooms in the county will receive a visit from their Assemblyman to recognize their top participation in TAKE ME TO VOTE!. This is scheduled for mid-January, with Assemblyman James Tedisco visiting Mr. Hanson's class in Stevens Elementary in the Burnt Hills Ballston Lake District, Assemblyman Robert Reilly visiting Mrs. Austin's and Mrs. Avenarius' classes in Skano Elementary in the Shenedehowa District, and Orenda Elementary with had 100% of the grade 5 classes participating enthusiastically. Assemblyman Tony Jordon will visit Dorothy Nolan Elementary in the Saratoga Springs School District to recognize that building's comparable level of classroom participation⁶

PROGRAM PLANNING—Your ideas are needed

Every two years local Leagues participate in the LWVNYS Program Planning process by reviewing existing positions and making recommendations for the future – *the input we all give allows us to remain a grassroots organization.*

The Program Planning process is an important League tool for identifying issues for study. It gives members and Leagues the opportunity to balance the pros and cons, assess possible support, and consider the viability of issues. **Program**, a three-part process that is a core component of the League's mission, is composed of program planning, study/consensus, and advocacy.

Our NYS positions are published in the **LWVNYS Impact on Issues** found on the LWVNYS home page under Advocacy Areas or at: <http://lwvny.org/advocacy/impact/impact.html> This is a lengthy document since it also contains the history of our positions, but one can also find a summary of our positions in the *Positions in Brief* section of the document, which will also be available at the meeting.

LWVNYS asks our League to answer the following questions:

1. Does your League wish to retain the current program as it is?
2. Does your League wish to update any item(s) in the current program?
3. Does your League wish to drop any item(s) in the current program?
4. Does your League wish to propose a new program item for study?

The LWVNYS board will use the responses from all the local Leagues across NYS to make recommendations to be considered at Convention. Delegates attending the LWVNYS Convention on May 20-22 will have the final say by voting to “adopt the program” which includes approving a new study and making changes to existing positions.

Note: We will also discuss program planning for our LWV for the 2011—2012 League year. Think about issues you are interested in.

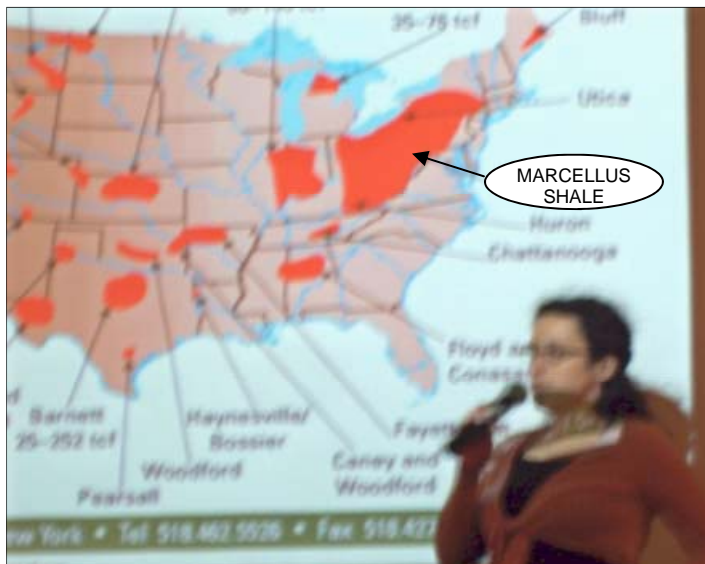
UPDATE ON HYDROFRACKING

After our November 17th discussion of hydrofracking (hydraulic fracturing) during which Katherine Nadeau explained the concerns of Environmental Advocates of New York about the possible water pollution from the hydrofracking process, the League officers asked if a member would write a letter to local newspapers on the issue. The goal was to press for legislation awaiting Assembly passage to delay any hydrofracking activity until the environmental concerns could be addressed by studies currently underway at the U S Environmental Protection Agency and the State Department of Environmental Conservation. Legislation had passed the NYS Senate initiating a six month moratorium. Although I missed the meeting, I volunteered to write the papers and with considerable help from Pat Nugent my letter went out.

Published in the Post Star and the Saratogian, it asked the public to call on Speaker Sheldon Silver to pass legislation to initiate a 6 month moratorium on horizontal drilling and hydrofracking. On Dec. 1, 2010 The Assembly passed the bill initiating a moratorium and since the bill had already been passed by the Senate it was sent to the Governor.

Governor Paterson vetoed the bill on December 12, 2010, because he said the bill would have applied to vertical wells currently safely operating in New York. There are currently at least 300 oil producing companies and 5,000 people employed in the field. However, he issued an executive order which will delay the use of the horizontal hydraulic fractur-

ing method until July 1, longer than the May 15 deadline in the legislation, and **importantly** requires DEC to release its new draft plan for public comment before final adoption. Incoming Governor Cuomo will be urged to let the Paterson executive order stand.

Now advocates have concerns that the executive order may have a loop hole which will allow vertical wells to contaminate water tables. Our League has acted on this issue based on a National League resolution supporting safe drilling of energy resources. It will behoove us to follow this story and seek further information once the studies come out or concerns about vertical drilling materialize.

received a sticker from the Board of Elections poll workers on their TAKE ME TO VOTE! Certificate as proof of “voting.” The Board of Elections accommodated the program and again this year supported League efforts to educate young citizens in the democratic process.

In some schools that librarian contact or a lead teacher spearheaded the entire initiative, garnering stellar student participation. Examples of these local leaders include Rebecca Manore from Shenendehowa’s Orenda Elementary, Mrs. DiBari from Shenendehowa’s Karigon Elementary, Mrs. Chynoweth from Joseph Henry Elementary in Gal-

way, Mrs. Schwartz in Schuylerville Elementary, and Andrea Williams in Ballston’s Wood Road Elementary.
